## Dear Community Member,

The Joshua Falls to Yeat Electric Transmission Line Project continues to take shape, with your input guiding the process. More than 4,000 community members attended open houses in March, providing key feedback both in person and online that has helped refine route options.

This 115-mile, 765 kV electric transmission line will connect the existing Joshua Falls Substation in Campbell County, Virginia, to a proposed new substation in Culpeper County, Virginia, and this project is vital to meeting our growing energy demands.

Valley Link Transmission released preliminary routes to the public in February, and we have spent the last few months listening to the community and making changes to those routes with the goal of minimizing impacts while delivering much-needed power. Route updates mean fewer residents will be impacted, along with minimizing impacts to environmental, historic and cultural landmarks.

Valley Link Transmission will release newly updated routes in late May. Our team will be back in your community to review the new routes and continue collecting feedback – see below for a list of open house dates and locations.
